If you wish to return your nomination form / forms by email you must
 - 1) Complete the form / forms by hand including all signatures and information required.
 - 2) Scan the document / documents and save as a PDF.

If an election is not contested the nominee shall be appointed. If an election is contested there shall be a ballot in which all Local Party members are sent ballot papers. The election shall be by Single Transferable Vote

- Members are reminded that nominations must be proposed and seconded for each position with signatures to show support of nomination.
- Members are reminded to use a separate nomination form for each position.
- Members are reminded that for a Nomination to count it must be received by the returning officer; it is up to candidates to check their nomination has been correctly accepted.

The executive will take office from 1st January 2019.
